Significant progress has been made with new Extension Field processing, which will allow NTF to integrate the work done on NTS (Network Time Security--the replacement for Autokey). Members of the organization participated in several IETF ntpwg (NTP Working Group) and NTS development meetings. Harlan Stenn submitted several drafts to the IETF for Extension Fields and NTS related code work.
